In case of OBU device failure in connection with notifications carried out in SMS and/or on the phone

(hereinafter referred as Customer), by signing present declaration I confirm that unless otherwise provided, in the event of defects of OBU On-Board units used by me, in connection with notifications that are to be carried out by i-Cell Kft. in SMS and/or on the phone to the above telephone number, the following procedure must be applied:

Notification in SMS I do NOT wish to receive I wish to receive AGAIN

Notification on the phone: I do NOT wish to receive I wish to receive AGAIN

Point 3.2. of the GTC of National Toll Payment Services states that: „Upon the Contracted Toll-payer’s written request and at its risks the Toll Declaration Operator has the right to refrain from sending a notice on errors affecting the Onboard Equipment. As a condition precedent to this the Toll Declaration Operator shall notify the Contracted Toll-payer of the risks involved in not receiving the notice, including in particular of the possibility of being fined for the faulty Onboard Equipment.”

As Customer I herewith declare that i-Cell Kft. has fully complied with its above obligation to provide information.

I also take notice that if I have provided the above telephone number also concerning other companies under my management in the HU-GO system, i-Cell will proceed under the above provisions in case of defects of OBU On-Board Units operated by i-Cell Kft. that belong to those companies.

- I am a registered customer in the HU-GO electronic toll payment system operated by the National Toll Payment Services Plc. (NÚSZ),
- As a Declaration Operator, I am in contractual relationship with i-Cell Kft. (Site: 1143 Budapest, Hungária köz 5., company registration number: 01-09-674965) for OBU On-Board units,
- I acknowledge that the legal relationship as Toll Declaration Operator between the Customer and i-Cell Kft. is regulated by the general terms and conditions of i-Cell Kft. on Declaration Operator contracts, by the Act V of 2013 on the Civil Code of the Republic of Hungary, by the Act LXVII of 2013 on distance-based tolls payable for the use of motorways, expressways and main roads as well as by the Government Decree 209/2013 (VI.18) on the enforcement of Act LXVII of 2013.
- I agree that data transmitted through present declaration as well as those transmitted by NÚSZ to the Declaration Operator about the Customer are managed by i-Cell in relation to the performance of the Declaration Operator contract according to the rules of the Act CXII of 2011 on Informational Self-Determination and Freedom of Information Kft. NÚsz shall forward the data to the Declaration Operator under the regulations applicable to it.
